## Overview

Acme Solar Holdings, through its SPV, has signed a 25-year Power Purchase Agreement (PPA) with Tata Power Company (Tata Power-D) for its 50 MW Firm and Dispatchable Renewable Energy (FDRE) project on Octo. The Letter of Award for the project was issued in September 2025. — energyRe, a leading developer of reliable and affordable energy solutions, today announced that it has executed 25-year power purchase agreements (PPAs) with one of the largest investor-owned utilities in South Carolina for five solar projects totaling 360 megawatts (MW) of. A Solar Power Purchase Agreement (SPPA) is a financial arrangement in which a third-party developer owns, operates, and maintains the photovoltaic (PV) system, and a host customer agrees to site the system on its property and purchases the system's electric output from the solar services provider. This month the Springfield City Council approved City Water, Light and Power's (CWLP's) proposal for a 25-year, solar contract for 25 MW of energy and capacity. The contract with Sangamon Solar LLC, is in conjunction with a new 100 MW, 750-acre solar installation to be built in Sangamon County. Lakeland officials have approved a 25-year contract to purchase renewable solar energy without having to make any upfront investments. City commissioners voted 6-1 Monday in favor of a power purchase agreement with Edge Solar LLC, a subsidiary of the Williams Corp., for exclusive rights to purchase. The PPA has been signed at a tariff of Rs 4.56/kWh, mandates a 40% minimum CUF and meets 90% of peak.
