## Outdoor communication base station equipment installation ...

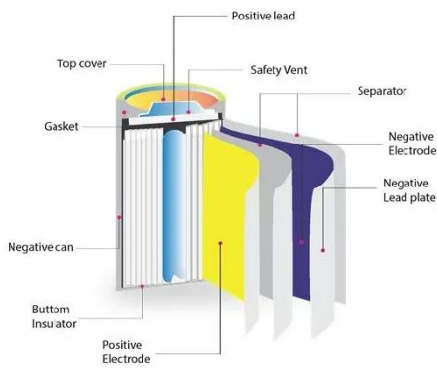
Yes, with a proper 12V DC power supply (3-5 amps minimum) and base antenna system. However, dedicated base



stations typically offer better features, ergonomics, and performance for home use.

**eCFR :: 47 CFR Part 1 Subpart U -**

(1) Base station. A structure or equipment at a fixed location that enables Commission-licensed or authorized wireless communications between user equipment and a communications network.
