Lawyers say the companies work in tandem to target seniors and low-income residents with misleading advertising and miscalculations of cost. Hundreds of these cases are already in arbitration, moving through discovery and scheduling. This fall will be extremely busy, with trials set to ramp up. By September or October, we'll have a much clearer picture of how.
