# **Solar panel exports have recently been blocked**



## Overview

The administration is announcing on Thursday that it's ending an exemption to import tariffs for solar panels that are double-sided, noting that since the exception was implemented, nearly all solar panel imports have been two sided. Court of International Trade (CIT) ruled that President Joe Biden's 2022 tariff pause on imported solar panels was illegal, and Customs and Border Protection (CBP) should not have followed it. These tariffs have significantly impacted the prices and availability of solar panels in the US market, leading to uncertainty and challenges for both consumers. The United States has stepped up its use of tariffs on international trade partners, alongside the removal of many renewable energy incentives.
